Kami mempunyai misi empat penjurong seperti berikut:

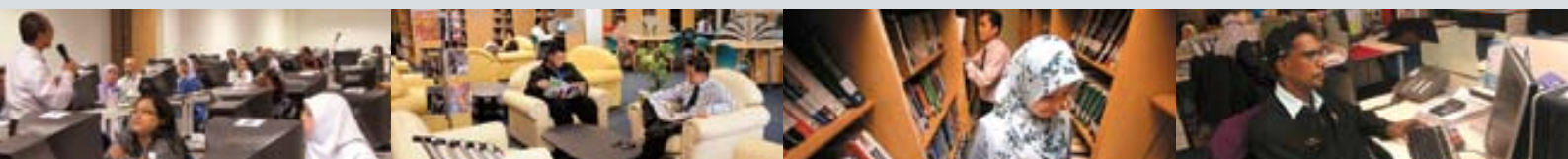
