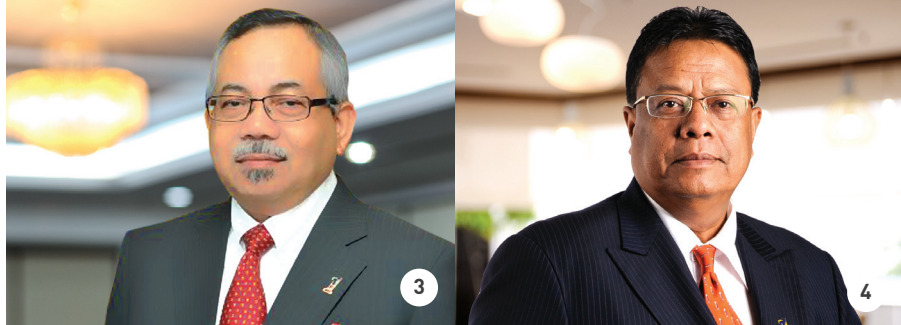

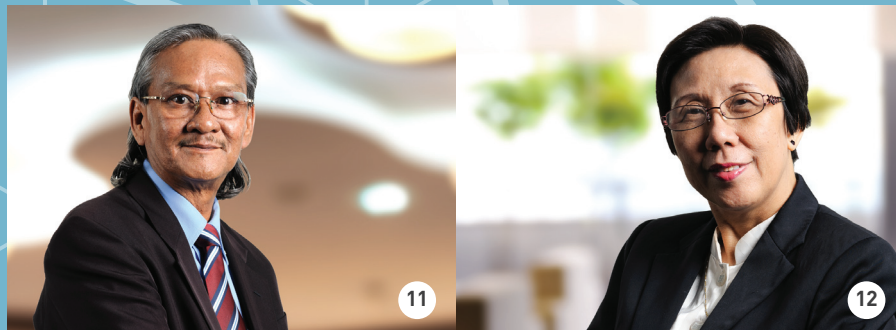

Tan Sri Samsudin bin Osman telah berkhidmat sebagai Pengerusi Lembaga selama 7 tahun bermula 1 Februari 2007. Tempoh lantikan beliau akan berakhir pada 31 Januari 2015.

Sebelum ini beliau pernah berkhidmat sebagai Presiden Perbadanan Putrajaya, Ketua Setiausaha Negara, Ketua Pengarah Jabatan Perkhidmatan Awam, Ketua Setiausaha Kementerian Dalam Negeri, Ketua Setiausaha Kementerian Perdagangan Dalam Negeri dan Hal Ehwal Pengguna, Setiausaha Persekutuan Negeri Sabah dan Timbalan Ketua Setiausaha Kementerian Pengangkutan.

Pada masa ini beliau memegang jawatan sebagai Pengerusi BIMB Holdings Bhd., Pengerusi Kwasa Land Sdn. Bhd., Pengerusi Lembaga Pengarah Universiti Utara Malaysia (UUM) dan Pengarah di Sime Darby Bhd. Beliau juga merupakan Pro Canselor Universiti Malaysia Terengganu (UMT), Canselor Kolej Universiti Bestari, Pengerusi Majlis Konsultasi Perpaduan Nasional (MKPN) dan Pengerusi Lembaga Pemegang Amanah Mahathir Science Award Foundation. Beliau memperolehi Sarjana Pentadbiran Awam daripada Pennsylvania State University, Amerika Syarikat.

Tan Sri Samsudin bin Osman has been Chairman of the Board for 7 years, beginning 1 February 2007. His current term ends on 31 January 2015.

Prior to this, he served as President of Putrajaya Corporation, Chief Secretary to the Government, Director General of the Public Service Department, Secretary General of the Ministry of Home Affairs, Secretary General of the Ministry of Domestic Trade and Consumer Affairs, Federal Secretary of Sabah and Deputy Secretary General of the Ministry of Transport.

He is currently Chairman of BIMB Holdings Bhd., Kwasa Land Sdn. Bhd., the Board of Directors of Universiti Utara Malaysia (UUM) and a Director of Sime Darby Bhd. He is also Pro Chancellor of Universiti Malaysia Terengganu (UMT), Chancellor of University College Bestari, Chairman of the National Unity Consultative Council (NUCC) and Chairman of the Board of Trustees of the Mahathir Science Award Foundation. He holds a Master of Public Administration from Pennsylvania State University, USA.

Beliau kemudiannya memegang jawatan sebagai Timbalan Ketua Setiausaha Perbendaharaan (Sistem dan Kawalan), di Kementerian Kewangan bermula pada Oktober 2011 sebelum menjadi Timbalan Ketua Setiausaha Perbendaharaan (Dasar) di Kementerian yang sama pada November 2012.

Beliau pernah terlibat secara langsung dalam persediaan pelbagai rancangan pembangunan lima tahun negara bermula dengan Kajian Separuh Penggal Rancangan Malaysia Keempat. Perkhidmatan beliau kepada negara telah diiktiraf menerusi penerimaan pelbagai anugerah termasuk Kesatria Mangku Negara pada 2008 dan Darjah Kebesaran Setia Mahkota Kelantan Yang Amat Terbilang pada 2009.

Dato' Mat Noor Nawi was appointed to the Board on 1 December 2012 as a Government representative. He holds a Bachelor of Science in Resource Economics from Universiti Putra Malaysia and a Master of Science in Policy Economics from University of Illinois Urbana-Champaign, USA.

He joined the civil service in 1981 as an Agriculture Economist at the Federal Agricultural Marketing Board (FAMA). He then began an illustrious, 29-year career at the Economic Planning Unit (EPU), beginning as an Assistant Director of the Distribution Section and culminating as the Deputy Director General 1. He was subsequently made Deputy Secretary General (Systems & Controls), Ministry of Finance beginning in October 2011 before becoming Deputy Secretary General (Policy) at the same Ministry in November 2012.

He has been involved in preparing the various Malaysia 5-year development plans beginning with the Mid-Term of the Fourth Malaysia Plan. His services to the nation are recognised through various awards which include Kesatria Mangku Negara in 2008 and Darjah Kebesaran Setia Mahkota Kelantan Yang Amat Terbilang in 2009.

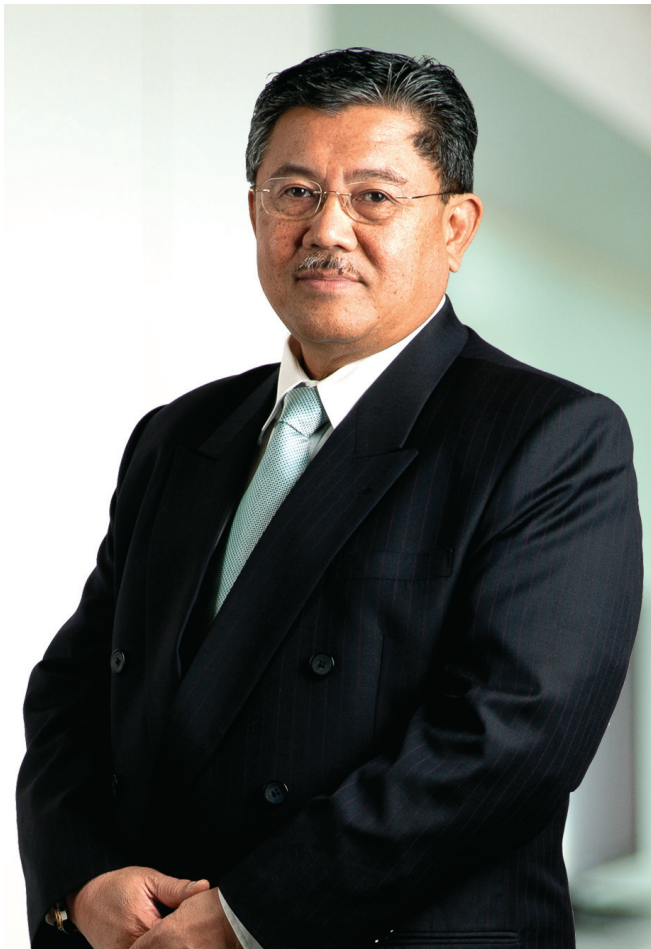

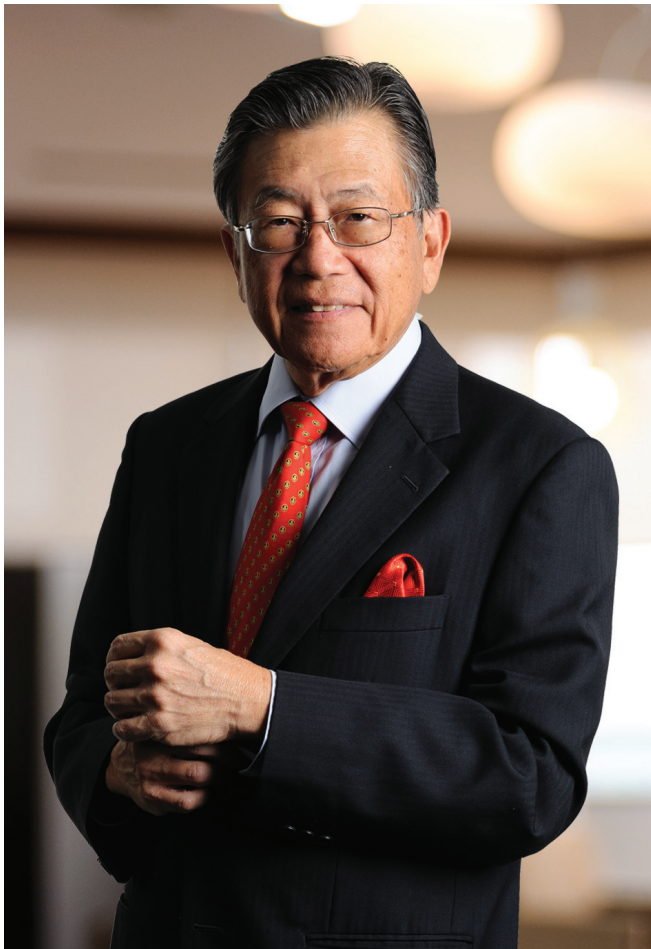
